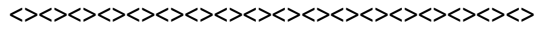

The resulting gifts represent a little over \$300,000 among 40 different agencies. The submission deadline for 2017 funding is midnight on December 31, 2016. Feel free to submit your application any time throughout the year between March 15 and the deadline. Paul and I will review all of the information and requests we receive in January and February and distribute contributions around March 1. We require only the completed Application Summary form found on our website (www.morrowrenewables.com), a copy of your Pub 78, and a copy of your Form 990.

For the benefit of the tax folks: The Paul and Katherine Morrow Foundation will provide grants to local, national, and international organizations organized as 501(c)(3) with emphasis on unity of the community, poverty, children, education, disaster relief, and other non-denominational religious organizations.

We support you with our time and our treasure with a great deal of trust. We typically won't specify how we'd like you to use any contribution, unless it's for a special project. In print, you may refer to us as Katy and Paul Morrow. Regarding special events, table sponsorships and the like, we try to attend as many functions as we can without taking too much time from the kids. Please don't waste postage on us throughout the year. This is a terrible admission, but your newsletters and direct mail solicitations are seldom if ever read (I wish you could see the guilty blush on my face as I even type this!).

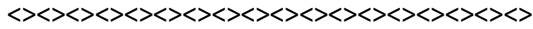

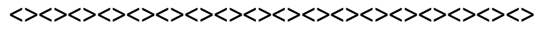
